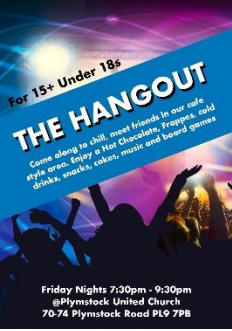

General Behaviour			
- Members should be caring, kind and polite. - Treat others with respect. - Help and support your group members and wider community. - Do not impose your opinion on others. - Alcohol or drugs should not be brought onto church premises / site. - No smoking on site. - Our staff are unpaid volunteers and should be treated with respect. - No violent or aggressive behaviour. - If arriving by scooter, motorbike etc, please switch off engines and don't hang around outside. - When arriving and leaving please be aware of neighbours and keep noise to a minimum.			
Discrimination			
- No member will discriminate against any other member of the group or public. - Bad language and prejudice are not acceptable. - Treat others with respect. - Bullying of any kind will not be tolerated.			
Confidentiality			
Members should keep personal or private information confidential and will not publicly discuss anything that might shame an individual.			
Breach of Code of Conduct			
- Anyone turning up to the Cafe intoxicated or found in possession of alcohol will be asked to leave. If this continues and the policy ignored, you will be banned from the Café. - Anyone found in possession of drugs will be asked to leave and police will be informed. - Aggressive behaviour will not be tolerated, and person or persons will be asked to leave.
